PROCEEDINGS OF THE POLK COUNTY BOARD OF SUPERVISORS

The Polk County Board of Supervisors met as a Canvassing Board on Thursday, November 8, 2007 at 1:00 p.m. to canvass votes cast for the Run-Off cities held November 6, 2007.

MEMBERS PRESENT: E.J. Giovannetti, Robert Brownell, Tom Hockensmith.

MEMBERS ABSENT: Angela Connolly, John F. Mauro.

For the Office of Mayor, City of Altoona (1 To Be Elected) there were 368 votes cast, of which Timothy J. Burget had 336 votes and Scattering had 32 votes. Timothy J. Burget was elected.

For the Office of Council Member At Large, City of Altoona (2 To Be Elected) there were 622 votes cast, of which Gerald B. Nolin had 269 votes, Stacey N. Warren had 259 votes, and Scattering had 94 votes. Gerald B. Nolin and Stacey N. Warren were elected.

For the Office of Council Member At Large, City of Clive (3 To Be Elected) there were 574 votes cast, of which Steve Brody had 185 votes, Scott C. Cirksena had 189 votes, John D. Edwards had 177 votes, and Scattering had 23 votes. Steve Brody, Scott C. Cirksena, John D. Edwards were elected.

For the Office of Council Member At Large, City of West Des Moines (1 To Be Elected) there were 1,284 votes cast, of which Jim Sandager had 1,209 votes and Scattering had 75 votes. Jim Sandager was elected.

For the Office of Council Member Ward 2, City of West Des Moines (1 To Be Elected) there were 855 votes cast, of which Rob Grove had 279 votes, Charles Schneider had 572 votes, and Scattering had 4 votes. Charles Schneider was elected.

For the Office of Park Commissioner, City of West Des Moines (3 To Be Elected) there were 1,718 votes cast, of which Forrest L. Ridgway had 1,121 votes, Colleen Armstrong (Write-In) had 79 votes, Rick Messerschmidt (Write-In) had 301 votes, Sandy Smith (Write-In) had 35 votes, and Scattering had 182 votes. Forrest L. Ridgway and Rick Messerschmidt were elected and one to be elected.

For the Office of Council Member At Large, City of Windsor Heights (2 To Be Elected) there were 1,151 votes cast, of which Charlene Butz had 400 votes, Colleen Carlson had 249 votes, Donna Keller Markley had 192 votes, Steve Peterson had 302 votes, and Scattering had 8 votes. Charlene Butz and Steve Peterson were elected.
